1. CALL TO ORDER

The Montgomery College Board of Trustees convened by videoconference at 9:32 a.m. on Thursday, September 9, 2021, to begin the first day of a two-day public retreat.

2. ROLL CALL

A roll call of Trustees was taken to establish a quorum.

3. APPROVAL OF AGENDA

On a motion from Trustee Suggs Smith and seconded by Trustee Morales, the agenda was approved.

4. WELCOME AND OPENING REMARKS

Board Chair Knapp welcomed attendees and thanked Second Vice Chair Lacey for serving as planning convener of the retreat during First Vice Chair Brintnall's work with presidential search activities. He opened the floor for each attendee to give brief check-in comments.

Both Dr. Dukes and Trustee Lacey also offered welcoming remarks, and Second Vice Chair Lacey previewed the two-day retreat agenda.

5. PUBLIC VOTE TO GO INTO CLOSED SESSION AND SUSPENSION OF PUBLIC RETREAT

Board Chair Knapp announced that pursuant to the General Provisions Article 3-301 and 3-305(b), the retreat meeting would be closed only to:

- carry out three administrative functions related to reviewing closed session minutes, receiving information on the presidential search, and discussing presidential succession and transition planning,
- discuss a personnel matter—subsection 1,
- discuss a personnel and privacy matter—subsections 1 and 2,
- consider acquisition of real property—subsection 3,
- to obtain legal advice on two matters—subsection 7, and
- to discuss a cybersecurity matter—subsection15.

Trustee Levey made a motion to close the meeting. Trustee Morales seconded the motion.

A roll call vote was taken and the motion passed.

No members of the public had objections to close the meeting.

Trustees then joined the closed session via Zoom videoconference.

6. MOVEMENT 2-TRANSFORMATION; FROM CONFERRING 2-YEAR DEGREES TO BACCALAUREATE DEGREES

Board Chair Knapp reconvened the public retreat at 1:00 p.m. on Thursday, September 9, 2021.

Dr. Dukes led a discussion of the perspectives and possibilities of Montgomery College becoming a baccalaureate degree-granting institution.

Board Chair Knapp reviewed several operational topics regarding policies, practices and protocols with the board.

A. FY22 Board Meetings

The board discussed their self-assessment timeline and possible documentation processes.

D. FY22 Presidential Self-Assessment and Evaluation Timeline

The board discussed the presidential self-assessment and evaluation timeline.

General Counsel Tim Dietz joined the retreat as a panelist.

Senior Vice President Collette provided the board with a status update on plans to require vaccinations for all students and employees of the College, that will be implemented in the coming months.

D. FY22 Institutional Priorities and Goals

Dr. Dukes, along with the chief of staff/chief strategy officer and the senior vice presidents, provided the board with a presentation of the proposed Institutional Priorities and Goals for FY22.

6. REFLECTIONS-UNDERSTANDING AND AGREEMENT ABOUT THE WORK AHEAD

Board Chair Knapp and Second Vice Chair Lacey thanked presenters and attendees for their engagement and expressed their enthusiasm for the year ahead.
