


## The Surgical Technologist.....




#### **Technical Standards**

**Technical Standards:** 

The student must possess sufficient physical and emotional functional abilities with or without reasonable accommodations.

Following a health history and comprehensive physical examination, a licensed medical provider will determine if this student demonstrates these abilities. If the licensed medical provider determines that the student is unable to meet the technical standards, they will provide an explanation and suggested accommodation(s); this may result in a Disability Support Services referral. If an accommodation is recommended, the student will be referred to Montgomery College's Disability Support Services for a consultation.

## Minimum Requirements

Minimum requirements that allow students to apply to the Surgical Technology program are the following:

- ENGL Foundation \*
- MATH Foundation \*
- Ø BIOL 212



- A minimum GPA of 2.5 based on the minimum and priority courses.
- Priority consideration for admission are BIOL 213 Human Anatomy and Physiology II and ENGL 102 Critical Reading, Writing, and Research

\*(if 5 years or older BIO 228 will need to be taken to supplement)

\* If you completed courses at the College prior to Fall 2017, you may use ENGL 101 and MATH 110 or higher.


## Career and Occupation Opportunities Outlook
