

## **Enrollment Agreement Between Montgomery College and Goucher College**

### **Purpose**

This agreement between Montgomery College (MC) and Goucher College (Goucher) recognizes the outstanding achievement of MC Honors students and seeks to provide for a seamless and successful transition from the MC Honors program to Goucher College.

### **Criteria**

Transfer students from MC Honors program are guaranteed admission into Goucher College during the Fall or the Spring semester provided the student has met the following criteria:

- Has applied to Goucher College, and met all requirements of admission to Goucher College,
- Has met or is in the process of completing all the requirements for the AA, AS, or AAT from MC,
- Has met or is in the process of completing all requirements for the MC Honors program prior to transfer to Goucher College
  - Confirmation required from the Coordinator /Administrator of the MC Honors program and
- Has earned at least a 3.5 cumulative GPA at the time of application to Goucher College.

### **Benefits**

Students interested in this program will be able to apply to Goucher with the application fee waived.

### **Other Provisions**

- Students meeting the above criteria will:
  - Be considered for a transfer merit scholarship up to \$17,000
  - Receive an additional \$2,000 scholarship if a member of Phi Theta Kappa
  - Receive an additional \$2,000 to for those students who have completed their AA/AS/AAT degree with a minimum of 12 honors credits and a minimum GPA of 3.5
- Both institutions agree to communicate annually to share information on curricular and program changes as well as all processes relative to this agreement.
- This agreement shall become effective upon the signing of both parties. The entirety of the agreement will be reviewed every five years and shall continue in effect until both parties agree in writing to modify or terminate the agreement. Termination of the agreement shall become effective ninety (90) days after written notice is given.
- Both institutions agree to abide by all State of Maryland and United State of America laws and adhere to FERPA regulations.

- This agreement replaces all previous agreements of the same nature.
- The office of record for Montgomery College is the Senior Vice President of Academic Affairs. The office of record for Goucher College is Office of the Registrar. These offices will serve as official recipients of the signed agreement and any updates or official notifications, and will provide implementation of this agreement as appropriate.
