- Integrating Census 2020 into Academic Census
 - What is the Census Bureau?
 - Serves as the leading source of quality date about the nation's people and economy
 - Also administrate other surveys
 - Helps our communities determine where to build everything from schools to supermarkets, homes to hospitals. Helps government decide how to distribute funds and assistance to states and localities.
 - Why does the Census matter specifically to MC?
 - Federal Pell Grant Program
 - Adult education grants
 - Federal and state transportation dollars
 - Agriculture, science, and engineering education
 - Community and mental health resources
 - School breakfast, lunch, and afterschool programs

- o Census 2020 Resources
 - Montgomery County 2020 Census
 - Montgomery College 2020 Census
 - National Census 2020
- Hired 18 student ambassadors from across the College to promote and inform
 - 10 question survey asking about people's current knowledge and attitude towards Census
 - About 15% are extremely concerned about filling out Census
 - About 50% of the students are not aware of it
- What about homeless population and international students?
 - Working directly with related groups/institutions to ensure that they are counted
 - Counts every human being visiting in the US
- o Based on where you sleep and live the majority of the time
- o Incomplete form will not be fined
- Looking for more Census workers
- \circ 4/1 is the cutoff date
- o Illegal for Census workers to share
 - Data becomes available 72 years later
