#### **Staff Council Recommendation- EAP Funds Communication**

Shane Doyle motioned and Tracee Matthias seconded to discuss that the Montgomery College Staff Council respectfully requests that Montgomery College:

- Add to the HRSTM website a widget that continuously shows the amount of EAP funds currently remaining without the need for anyone to manually update the website as funds are used.
- Prominently add to the HRSTM website, and future communications to the College community about EAP, an explanation of the fact that employees can encumber EAP funds in advance and the process by which one would do so.
- Send more frequent email updates about the remaining EAP funds available throughout the year.

# **Purpose:**

To ensure non-bargaining staff is better able to plan and utilize EAP funds before they run out each year, especially those who might be using EAP for the first time and are unfamiliar with how quickly funds run out and how the process works.

Tracee Matthias moved to amend the third bullet to state:

• Send email updates when 30% of the remaining EAP fund are available.

Tracey Smith-Bryant seconded the motion.

Shane Doyle moved to amend the third bullet for the second time to state:

• Send an email when any EAP fund has only 30% left, and also when there is only 10% left.

Tracee Matthias seconded the second amendment. Tracee Matthias motioned to resend her previous amendment and make Shane Doyle's amendment the only amendment. The amended recommendation received a unanimous vote.

Cathy Giovannetti passes the motion.

Dr. Clevette Ridguard presented to the College Council the bylaws and the constitution sections regarding the elections of College Council Chair.
