## **Employee Services Council Constituencies Concerns**

Liaison from the Staff Council presented a constituent concern; the concern is inference to the
memo sent out to the college community from HRSTM about the minimum wage rate. The liaison
states it has been the college's practice to follow the Montgomery County minimum wage rate with
the \$15.00 hourly rate going into effect on January 1, 2022. Montgomery County increased their
minimum wage rate to \$15.00 an hour on July 1, 2021. Montgomery College employees whose
wages are tied to the minimum wage rate are student assistants and casualty temps. It is not fair to
deny the employees 6 months of additional earning power. Moving the college's effective date for
minimum wage increases to align with the county should not pose an undue hardship on the payroll
department. It sends a signal that some employees are not more equal than others, we are ONE

college. ESC will follow-up (tabled).
