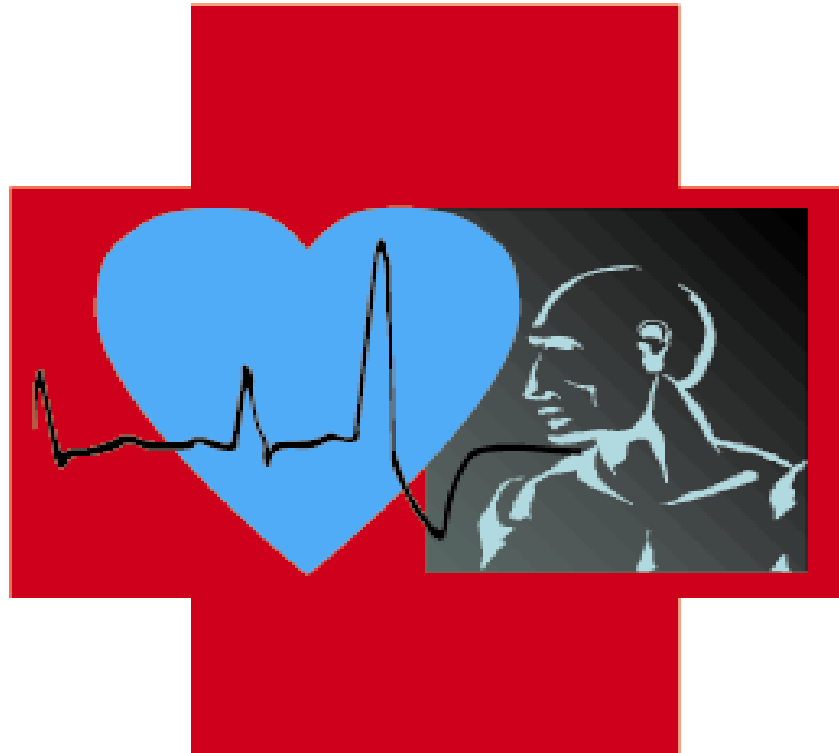

Health Sciences Checklist

Obtaining your education in one of our seven Health Sciences programs can start you on a rewarding career in the medical field. Graduates of our programs are competent and prepared to apply to take the various certification examinations to be successful in the medical community. To get started, complete the following steps.

1. Attend an Information Session

Attend an Information Session for your area of interest. It is in your best interest to attend an Information Session so that you will understand the nature of the program, the admission process and the rigor and time commitments needed to be successful in these programs. Times and dates can be found at www.montgomerycollege.edu/healthsciences.

2. Visit the Office of Admissions

Submit a Montgomery College admission application with a non-refundable \$25 fee, and if applicable, official copies of your college transcripts to the Office of Admissions for review. Once you receive your transcript evaluation, it will help you to ensure that courses are not duplicated. Make sure you obtain a college catalog and review which classes you will need to take.

3. Make an appointment, for *Nursing, RT, and PTA Only*, to take TEAS Test

Before applying to the Nursing or Radiologic Tech Program, you must meet minimum academic requirements (see application). To assess these skills, set up an appointment to take the TEAS test at the testing center or at any institution that offers the test. 4. See a Counselor

5. Apply to a Program

Once you have completed all of your requirements (see page 3), submit your Health Sciences application to the Office of Admissions before the deadline: March 1st for Fall Admissions (all programs) or July 1st for Spring Admissions for Nursing only. Admission Requirements Update--Please read carefully.

Montgomery College Health Sciences programs requiring this application are available ONLY at the Takoma Park Campus. (Please note: there are two applications-one for admission to the college and this application.) In order to apply, you must meet all of the following requirements **before applying**:

- You must submit an application for general admission to Montgomery College along with a \$25 non-refundable fee (if not previously admitted.)
- You are strongly encouraged to attend an Information Session for your area(s) of interest.
- Minimum requirements needed:
 - EN 101 assessment level or prior completion of EN 101/101A/102 or 109
 - BI 107
 - MA 110 assessment level or prior completion of MA 100 or higher
 - Additional for DMS applicants: PH 010 or higher
 - For Polysomnography only: EN101/101A and RD 120
- Must have a minimum GPA of 2.50 for consideration. This GPA is based on your most recent 24 college credits earned. If you are a recent high school graduate with fewer than 24 college level credits, secondary school records will be included in this calculation. Official transcripts are required.
- ***Nursing and PTA Applicants-TEAS test scores required***- GPA will be used for eligibility purposes only. You must complete the TEAS admissions test and attach scores to this application. **You must have the minimum Adjusted Individual Scores or above in the following subjects: Reading=84%, Science=60%, English=72% and Math=48%.** **Students may only take the test twice during a twelve month period. The most recent test score will be used.** The Adjusted Individual Total Score will be used to rank eligible students.
- ***Radiologic Technology Applicants –TEAS test scores required***-GPA will be used for eligibility purposes only. You must complete the TEAS admissions test and attach scores to this application. **You must have the minimum Adjusted Individual Scores or above in the following subjects: Reading=74%, Science=50%, English=72% and Math=35%.** **Students may only take the test twice during a twelve month period. The most recent test score will be used.** The Adjusted Individual Total Score will be used to rank eligible students.
- The following courses give priority for admission. Applicants who have completed all of the listed courses for their program of choice will be given first consideration over those students who have not. You may apply without completing any of the priority courses; however, this will make you less competitive for admission. **Those identified for each program are:**

Additional Details about Admission Requirements

Please Note:

- **BI 204 and BI 205 courses older than five years of the application deadline will not be accepted.**
- Students who transfer to Montgomery College with BI 204 and/or BI 205 will not need to complete BI 107.
- Reminder—Please refer to the college catalog to review all course prerequisites.
- **Polysomnography:** If there are more applicants than spaces, applicants will be ranked by GPA and the first 25 students will be admitted. There are no Core Courses required.
- **TEAS Update--Please note:** The minimum Adjusted Individual Score for English has changed from 74% to 72%.

Health Sciences admissions will be based on courses completed and grades earned through the prior fall semester only. Spring admission (Nursing only) will be based on courses and grades completed through the prior spring semester only. (Example: If applying for Fall 2010 (March 1st deadline), courses completed by Fall 2009 will be used; if applying for Spring 2011 (July 1st deadline), courses completed by the end of Spring 2010 will be used).

III. **Notice of Additional Enrollment Requirements (subject to change)**

All candidates who are offered admission to a Health Sciences Program should be aware of and prepared to meet these additional requirements prior to enrollment and licensing.

- Must understand and meet all requirements and/or standards imposed by recognized professional societies and all contract requirements imposed on College students by the institution or agency where the clinical practice is to occur.
- Must understand and be prepared to meet all requirements for participation in certain clinical courses involving hospital or clinical practice. These requirements may include the passing of an appropriate health examination and tests per CDC guidelines, e.g.: (1) complete blood count; (2) urinalysis; (3) a complete hepatitis B vaccination series (series of three or waiver); (4) annual TB screening; (5) MMR vaccination(s) or positive titer(s); and (6) varicella vaccination or a varicella titer.
- Must understand that drug testing and criminal background checking of nursing and health science students are required by the facilities which are the sites for the clinical learning experience of nursing and health science students. These are conducted by an outside agency at the student's expense and must occur before a nursing and health science student can be placed at a facility for his or her clinical experience. The results of drug tests and criminal background checks will be available for review by designated personnel in each clinical facility and the clinical facility has the right to refuse admission for students based on such review.
- Must understand participation in certain clinical courses may require a current CPR for Healthcare Provider certification that meets standards acceptable to the facility or clinical site before beginning the student's Clinical Rotations.
