**Middle States Self-Study
Listening Tour Sessions
Spring 2017**

During this series of 90 minute workshops, participants will review and share input for the revision of the first chapters of the Middle States report. One activity will ask participants to work in small groups to respond to open questions from the workshop with a focus on content and the study recommendations. A second activity will provide participants with the opportunity for broader discussion and general feedback. These activities will require participants to review the 12-14 page drafts in advance of the session in order to provide the workshop with meaningful feedback. Participants may register for one or two spots in advance of the session sessions with fewer than 2 registrants will be canceled.
