# Power Point Presentation by Sharon Bland, Chief Equity and Inclusion Officer, about what the Equity and Inclusion Office does

Highlights:

- The President's Advisory Committee on Equity and Inclusion (PACEI) has been developing what equity and inclusion best practices look like at Montgomery College and has been making recommendations about equity and inclusion to SALT and to the President
- There will be college-wide memo sent out that delineates the results of the Employee Engagement survey that PACEI sent out to all employees
- Goal is to strengthen employee morale
- Fear and incivility are people's biggest concerns
- Equity in pay is also a concern
- PACEI is implementing a leadership training and coaching program for all managers, including the SALT team, to increase leadership effectiveness at all levels of the College
- Sharon will be producing a score card for Montgomery College
- Equity Summit will be held on April 30, 2019 on the Germantown campus
   The event will be live-streamed

### Chair Report

- College Council Meeting notes:
  - Budget hearings effecting MC are being held by the County Council
  - o MC elections for governance councils will be held in May
  - An MC video is now being shown to encourage voting for new governance members.
  - The College Council approved a recommendation proposed by the Staff Council

- to continually display the amount of EAP funds available to MC staff
- The College Council approved a resolution proposed by the Staff Council to formally thank MC Management for releasing the Executive Summary of the latest Equity and Inclusion Survey to the entire College community.
- Tracy Smith was elected Chair of the College Council
- A new Vice Chair and Secretary will be nominated by the College Council on May 14, 2019
- Dr. Monica Brown and her associates Dr. Bartolomeo and Dr. Gregory presented an overview and highlights of the Student Affairs Master Plan (STAMP) and the Strategic Enrollment Management Plan involving efforts to improve student outreach and onboarding initiatives.
