**Student Registration Process Discussion** – Ernest Cartledge, Director of Records and Registration and College Registrar

 At the end of Spring 2023 an update for the College's registration process was rolled out. The update did not address the issue our Council brought up last year. In particular, the ability to register for all linked CRNs at the same time (e.g. lecture + discussion + lab).

- Can we keep the back-end (internal structure) the same but change the front-end (external) user-experience for our students?
  - This is a discussion that needs to happen with IT
  - Example: Coursicle.com
  - MC has explored schedule building software but has not pursued any procurement of any software
- Can we make how-to-register videos for students or offer info-sessions for students?
  - This can be a provisional solution until the registration system can be updated or fixed
  - Registrars' Office will work with MC TV to produce updated videos
- There are currently two ways students can register: the old system and the new system
  - It has not been decided when the old registration system will go away, it will depend upon usage of levels of old and new system
  - The College recognizes the registration issues and Dr. Williams is working on this with the Enrollment Management office headed by Dr. Kimberly McNair
- Payment reminder email sent to students upon registration
  - Students are dropped for non-payment 3 weeks prior to the semester begins.
  - Words such as "you must pay today" and "if you are expecting financial aid to hold your classes immediately contact them" can be anxiety provoking
  - Add a general contact such as Raptor Central for students who don't know which office to contact
  - This email is sent periodically if their account has an outstanding balance, which could result in students receiving the email after they have made payment arrangements if the payment has not been posted
  - There is a welcome letter sent to students when they apply to the College, which students receive prior to registration
  - Council members will work on editing the email and send back to Ernest with our recommendations
- Can we add a link in the course listing to a pdf of the syllabus?
  - Yes need discussion with IT but should be technically possible

# Old/New Business

## Constituency Concerns - Elysse Meredith

- Privacy concern with Examity Live Proctor and non-compatibility with Mac computers
  - Guillermo Laya, Assessment Center Director, is working with Examity to address these issues
  - o Examity provides resources to help faculty and students on their website
  - Assessment Center staff also aid faculty and students with using Examity, including zoom office hours
  - Specific data and testing information from the specific students experiencing the issue is needed to further pursue solutions
  - o Guillermo will attend the Council's December meeting

- Courses requiring testing through Examity can include a note to this effect on the course listing
- o Recommend that the syllabus template include testing options for the course
- What is the standard testing format for each course?
  - Distance learning classes distance exam
  - Hybrid classes?
  - Hyflex classes?
- Can we provide "virtual desktop" for students to use with Examity to eliminate some of the technical issues?
  - These come at a cost to the College
- Can we have students VPN into computers at the Assessment Centers?
  - We need to ask IT
- INK Printers
  - o Sokol Mato, Director of Auxiliary Services, oversees the printers
  - Most printers have been serviced and are working
  - $\circ$   $\;$  Attach to each printer a map with locations of all printers in each campus  $\;$
  - Elysse will take this concern
- CMSC 216 has only one professor and one class available for all three campuses
  - ENEE 240 and Biology for Engineers class are in the same situation
  - This is an enrollment issue not enough enrollment to be able to offer multiple sections to meet the 85% filled-seats (this is when the budget balances)
  - The SET area chairs are looking into better times for scheduling these courses
  - Nawal will take this concern
- Bathroom doors at TPSS campus
  - Jack met with Ali Fadl to address the issue
  - The doors are still not opening automatically
  - The doors are working well in the Commons but not in the ST or Science Building
  - Jack will take video of the doors to show the difference and email Ali to show what the problem is

## Council FY24 Goals – Tilandra Rhyne

- ASC Goal #1
  - Dr. Ridguard's recommendation: identify gaps between services and support the College offers and what the students are aware of, then make recommendations to the various offices on how to better advertise their services to students
  - New wording for Goal #1: The Academic Services Council will investigate touchpoints of how new and returning (credit and non-credit) students are informed of how to access academic and support resources, identify what is readily available, and make recommendations to help fill identified gaps
  - o Zahra will use ASC social media accounts to help promote our goal
