Council Reports:

- Student Services, as reported by Ernest Cartledge, discussed council goals and referred WEPA card issues to the Operational Services council.
- Operational Services, as reported by Ed Riggs, had the following constituent concerns: Two-Factor Authentication (2FA) issues and that Adobe Suite will not be updated.
- Faculty Council, as reported by Timothy Kirkner, discussed goals, the makeup of the council membership, and a focus on action over information sharing.
- Employee Services, as reported by David Torain, received constituent concerns that are being investigated by three research teams made up of membership to include: teleworking, special recognition awards, and course release time for faculty doing research.
- Student Council, as reported by Caleb Schauer, discussed goals around awareness of the council.
- WD&CE Council, as reported by Joe Marshall, elected a new vice chair and the goal discussion included blackboard equity for student access and creating a partnership with advising.
- Academic Services, as reported by Colleen Dolak, held introductions, elected a new vice chair, will continue to work on goals from the previous year, and will use Microsoft Teams for communicating.
- Germantown Campus Council, as reported by Paul Jenkins, had no new updates.
- Rockville Campus Council, as reported by Christine Tracey, had no new updates.
- Staff Council, as reported by Shakenna Adams-Gormley, filled four of the five vacancies, received six constituent concerns including shuttle during summer, parking permits that clearly identify MC as the place of employment, comment form not working on the homepage, OSHA training and question of staff having to pay out of pocket, and special recognition rewards were referred to Employee Services Council. Christopher Moy needs one or two governance council members for the Title IX Advisory committee which will meet in October, February and May, email him if you have any interested members.
- Administrator Council, as reported by Janee McFadden, revised goals, formed a subgroup to brand the council, and will have a guest speaker at meetings.

- Working on filling in the vacancies of all councils

A discussion continued on modifying the bylaws and Tracey Smith-Bryant asked Colleen to work with Caleb on bylaw recommendation; David and Janee had comments as to the merits of a bylaw amendment.
- Tracey Smith-Bryant reminded everyone to send a proxy in your place and requested that every member bring a constituent to the October 22nd meeting.
