### **Call to Order**

• The regular meeting was called to order at 12:01 pm by Dana Baker, co-chair. There was a quorum to conduct business.

### Approval of the Agenda / Minutes

Vedham Karpakakunjaram made the motion to approve today's agenda, Norma Winffel seconded the motion. Today's agenda was approved unanimously. Norma Winffel made the motion to approve the minutes as written, Jon Pointer seconded the motion. The minutes from May 6, 2021, were approved as written with two abstentions. The meeting was recorded for internal use only.

### **Chair's Report**

Dana Baker informed the membership that a vice chair is needed and explained that Chloe Martin resigned from her position over the summer due to additional work constraints. Rebecca Thomas advanced from the vice chair to co-chair position. Rebecca Thomas provided an update on the ad hoc committee tasked with developing a syllabus addendum and classroom guidelines. The ad hoc committee worked over the summer to construct the "Syllabus Statement, COVID Health and Safety Guidelines" and "Classroom Guidance During COVID-19." The council has received positive feedback from its constituents regarding these materials. Members of the ad hoc committee were recognized and thanked for their work on this committee. Rebecca Thomas reported that the council sent the names of thirteen full- and parttime faculty members nominated to serve on the Presidential Search Committee. The nominees represented all three campuses. The Board of Trustees and the Chair of the Presidential Search Committee will make the final decision about who will serve on the committee.

## **Committee Reports**

- Collegewide Curriculum Committee Report was reported by Vedham Karpakakunjaram.
  - The committee reported one vacancy and nominated Dr. Bonita Parker to fill the vacancy. Shelley Jones made the motion to accept the nomination, Chloe Martin seconded the motion. The council voted unanimously to accept Dr. Bonita Parker as the newest member of the Collegewide Curriculum Committee.
- General Education Standing Committee Report was reported by Michelle Prendergast.
  - Michelle Prendergast reported that the committee worked on the General Education website to streamline the general education appeals process.
  - Michelle Prendergast reported that the Information Literacy rubric is in progress of collecting feedback from the Deans and Chairs regarding the rubrics.
  - The committee reported a vacancy and nominated Dr. Norberto Gomez to fill the vacancy. Rebecca Thomas made the motion to accept the nomination, Vedham Karpakakunjaram seconded the motion. The council voted unanimously to accept Dr. Norberto Gomez as the newest member of the General Education Standing Committee.
- Academic Regulations Committee Report was reported by Norma Winffel.
  - Norma Winffel submitted the committee report via email on September 2, 2021. The status of the Priorities Completion Report was attached.
  - Norma Winffel reported that there are two vacancies on the committee: a Germantown Faculty Representative and a Takoma Park/Silver Spring Counseling Faculty Representative. The committee will present nominees for the vacancies at the next meeting.

  - Staying in touch with our constituents; showing engagement & appreciation for them; invitation different constituencies (disciplines) to faculty council meetings to highlight work in their areas.
  - Faculty are often overwhelmed with emails. Instead of sending emails, Shelley Jones recommended that we send a questionnaire to full- and part-time maybe three times a semester asking them to share their feedback about concerns or recommendations for ways the College can offer support to help faculty do the work of the College.
  - Completion of current ad hoc work groups: Inclusive Syllabus Redesign, Faculty Service Awards, COVID Classroom Guidance.
  - Virtual etiquette: Zoom / collaborate ultra-etiquette should be included in our ad hoc syllabus template.
  - The co-chairs will develop goal statements from the discussion points above.

Vedham Karpakakunjaram made a motion at 1:37 pm that the meeting be adjourned. Anestine LaFond seconded the motion. The motion passed with unanimous support.
