Call to Order

The regular meeting was called to order at 12:00 pm by Anestine Theophile-LaFond, co-chair. There was a quorum to conduct governance business.

Approval of the Agenda / Minutes

The agenda for today's meeting was approved as written (Motion: Dana Baker, Second: Teri Hurst). Minutes from October 19, 2023 were accepted with corrections (Motion: Brandon Wallace, Second: Diego Hernandez). This meeting was recorded for internal use only.

Constituent Concerns

At this time, guests were invited to speak by Dana Baker:

- 1. Follett book order does not reflect actual class size– Matter sent to Book store director. Vice Chair Dana reported that the bookstore flooded and lost some of its inventory. The bookstore is now in the process of upgrading its inventory.
- GT faculty concern about minors on campus concern about college effort to educate the college community about obligations with minors on campus. Some may not be aware of all the laws. Concern was sent to Kristen Roe, Director of ADA Compliance and Title IX Coordinator. May make recommendation to make mandatory training about laws surrounding minors.
- 3. Antonio informed that faculty are already having to do criminal background check and finger printing, which are all issues associated with dealing with minors.
- 4. Harry expressed concern that criminal background checks and fingerprinting are required by MC to interact with minors. If there are going to be more minors on campus as a result of increased dual enrollment, he questioned whether all faculty members going to be required to undergo criminal background checks and fingerprinting.
- 5. Dual Enrollment students applying for college, the use of Common App is problem Dual enrolled students are listed as high school students, when they apply for recommendation from MC faculty it is difficult to get the recommendation. Dana to make available to council the document from Director of Safety for minors, plus document provided to counselors.

- Math representative Stephen Perencevich needed approval of council. Council voted to approve Steven.


• Academic Regulations Committee (Regs) : Diego Hernandez

• Senior officials are not complying with the approval process as obtained in the P & P as follows:

The current P&P state that after Faculty Council, the SVP for Academic Affairs has last and final approval of any new or modified academic regulations. Instead, after proposal leaves Faculty Council, the regulation goes to the COO group of all SVPs and chief of staff then to the Presidential Advisory Council. This departure from the P & P has added an additional administrative layer which impacts the efficiency of the process and has been deemed of grave concern to the Academic Regulations Committee. Diego reported that this new procedure has impact on student success, counselor and advisors' ability to do their jobs and is demoralizing to the Academic Regulations Committee. Possible outcomes: P & P modified to reflect the new process or there should be a return to the existing process. Antonio recommended that the matter should be addressed and reported on at next FC meeting.

- A Dean representative still needed. Recommended dean has not responded to communication from Academic Regs.
