Call to Order

Chair Cartledge called the meeting to order at 3:01 p.m.

Constituent Concerns

- Eurae Muhn raised concerns surrounding student wellness in regard to current atrocities happening globally (especially in relation to her own student, whose family members were recently murdered in Gaza, and students who have experienced hate crimes on our campuses in response to the genocide in Gaza).
- In response to Eurae's concern, Dr. Brown shared that administrators have met with students on listening tours and that notes from these meetings have been shared with Dr. Williams and his cabinet. Students have been asked for suggestions surrounding this matter.
- Dr. Mason has not received any reports of hate crimes. Eurae suggested that communication condemning hate crimes as well as steps to reporting hate crimes be sent out to the entire community.

Presentation: Guest Speaker Ja'Bette Lozupone

- A Student Parent Advisory Group (SPAG) has been formed. They meet 2x a semester, while 5 workgroups meet more regularly.
- Aims to accelerate academic careers for student parents.
- MC has received a seal for being Family Friendly and has been named an exemplar institution—recently won \$25,000 grant
- Plan to collect data and identify student parents, build family friendly spaces and resources, increase student parent engagement and outcomes
- Data collection will happen through admissions applications/registration
