WDCE Updates

Dr Carolyn Terry, Associate Senior Vice President for Academic Affairs

- Final Board of Trustees meeting was last night (Dr. Terry will share slides)
 - Partnerships, marketing, communication and outreach updates
 - Steve Greenfield was missed (out sick)
 - Responding to concern from Natasha: marketing and outreach was a big topic at the meeting; there are opportunities to grow and improve here
 - Notes on WDCE enrollment & appreciations
 - 100 staff (full-time staff and faculty); 500-600 PT faculty
 - Appreciation and recognition shared by trustee Aparicio Blackwell for the hard work and dedication of staff
 - Appreciation for how strategic and difficult it is to maintain the balance in WDCEso much dependent on grants, fluid funding, staffing challenges, etc.
- Upcoming meeting this Friday to talk about Lumens which will be used for registration and also marketing going forward
- Suggests creating a refreshed strategic plan for WDCE

 - Yes! Reach out and we can talk about developing something (real time or asynchronous)
- Dorothy: What is ELITE's perspective on AI and how it will affect our work and our students/curricula?
 - We have been at the forefront of providing information about AI recently, specifically
 ChatGPT- we have offered 15 learning opportunities about AI this year so far.
 - Dr. Miller delivered a recent 60-minute training to faculty council about ChatGPT and implications thereof with a focus on how we can coexist with AI.

Guest speaker: Kristen J Roe

Director of ADA Compliance and Title IX Coordinator

- Title IX and ADA both fall under the Office of Compliance, Risk and Ethics
- A common guestion is why they are bundled together.
 - Answer: They are both civil-rights based federal regulations. Both remove barriers of all kinds for students. ADA and Title IX apply to staff/faculty, students, visitors - everyone

Title IX

- Mission is to reduce or eliminate barriers to educational opportunity caused by sex discrimination in institutions that receive federal funding.
 - Ensure that we are not deliberately indifferent.
- Title IX Sexual Harassment
 - Awaiting new guidance next month- some changes may be coming in the Fall as a result
 - o Three parts: refer to PowerPoint Ms. Roe will share for exact legal definitions
- Incident Reporting
 - If someone shares with you that they have experienced something, Ms. Roe recommends sharing the supportive measures first [refer to PowerPoint slides], as these often are the most meaningful to individuals
 - We are all obligated to report sexual misconduct to the Office of Compliance, Risk and Ethics. You should let the person who shared with you know that you are required to share the information with Title IX. The office staff will reach out to them to gather information and share options
- Gender inclusive restrooms and chosen name policies are also covered under Title IX
- Title IX also covers things related to pregnancy
 - Students who are experiencing pregnancy and pregnancy related conditions (including childbirth, miscarriage, termination of pregnancy etc.) have rights afforded under Title IX
 - Likely these requirements are going to be more strict based on the federal regulation changes around who is required to share information with students
 - Lactation suites open to anyone, request through Title IX for ongoing access or call public safety for one-off access

ADA

- ADA: ensure equal access and opportunity for individuals with disabilities
 - Important to understand obligations at minimum
- To receive an accommodation, students must self-identify to the DSS office
- The College is engaged in ADA self-evaluation to look at accessibility
 - Based on data from focus groups etc., it looks like WDCE students are less likely to request accommodations. They are looking to figure out why this is. There are additional upcoming focus groups and results sharing sessions.

Question from Transcie

What support can we provide our instructors when students do not disclose?

 This is a difficult position for instructors to be in– recommends that they reach out to DSS counselors about this.
