\*The maximum FWS award is approximately \$9261. The rate of pay is adjusted to stay consistent with state and county minimum wage requirements. For the 2024-24 award year the estimated wage is \$17.15 per hour fall 2024 and spring 2025. Students are permitted to work an average maximum of 15 hours per week.

\*\*An estimated, offered Direct loan is initially the maximum subsidized and unsubsidized loan amount, according to the student's year in school and dependent/independent status. Students may receive lower amounts of subsidized or unsubsidized loan, depending on their eligibility and or individual student request.

**Other Notes:**

BOT Grant will not package for students with an SAI above 20000 and out of county students. Exceptions are approved, on a case-by-case basis. For PKS1, BOT Grant is awarded after FSEOG is expended. In some cases, BOT Grant will not authorize for less than half time enrollment. Adjustments for less than half time students may be made on a case-by-case basis.

Award eligibility reviews:

**Awarding:**

At the time of awarding, the system is set to review all eligibility requirements for each aid program to determine a student's eligibility for a particular award and appropriate amount.

**Authorization:**

At the time of authorization, the student's eligibility is reexamined by the system to determine if the student remains eligible for the aid type and amount and adjust if required.

**Disbursed:**

Disbursed aid is monitored weekly, based on type of aid, through automated processes or system generated reports to ensure students remain eligible for types and amounts of aid received.
