GRADUATION/TRANSFER RATE – STUDENT RIGHT-TO-KNOW DISCLOSURE

In accordance with the Higher Education Act of 1965, and the Higher Education Opportunity Act of 2008, Montgomery College is reporting the graduation and transfer rates of students who entered the College in Fall 2019 as first-time, full-time, degree or certificate seeking students. The graduation and transfer rates are computed based on the student's status three years after entry.

Of 1,967 students who entered as first-time, full-time, degree or certificate seeking students in Fall 2019, 28.2% graduated and 20.1% transferred to a postsecondary institution within three years, making the Montgomery College combined Graduation/Transfer rate 48.3% for the 2019 entering student cohort. The data below reflect Graduation/Transfer rates of Fall 2019 cohort by race/ethnicity, gender, and financial aid status.
