We know that experiencing discrimination in any form can create barriers to your success and reduce the sense of belonging we seek to create. To support an educational environment free from discrimination, we are providing this notice to you and explaining how to report concerns.

Nondiscrimination Notice

The College prohibits discrimination against any person on the basis of age, color, citizenship status, current or former military status, disability, gender, gender identity and expression, genetic information, national origin, marital status, race, religion, sex, or sexual orientation.
