1. Statement of Use

On April 9, 2020, Montgomery College (MC) received notification that the College was awarded \$10,995,749 through the Coronavirus Aid, Relief, and Economic Security (CARES) Act, with no less than fifty percent (\$5,497,875) for Emergency Assistance Aid Grants to students. The guidelines from the U.S. Department of Education (ED) stated that these are direct emergency grants for students to cover expenses related to the disruption of campus operations due to the coronavirus (food, housing, course materials, technology, health care, and child care). The College must prioritize students with the greatest need and the funds may not be used to cover tuition and fees. MC signed the Certification and Agreement for the Emergency Financial Aid Grants to Students under the CARES Act on April 19, 2020, and received the allocation on April 24, 2020.

On February 16, 2021 Montgomery College received notification that an additional \$5,497,875 would be available to award to students through the Coronavirus Response and Relief Supplemental Appropriations (CRRSAA) Act. CRRSAA removed the requirement that a student must be eligible for Title IV aid to receive financial assistance under the HEERF programs and expanded eligibility to Nondegree seeking, non-credit, dual enrollment, and continuing education students. Students exclusively enrolled in distance education may also now receive these funds. CRRSAA requires prioritization of need and can be used to cover any component of student's cost of attendance, emergency costs that arise due to coronavirus, such as: tuition; food; housing; health care (including mental); and childcare. The grant can only be applied to tuition cost with the permission of the student.

On May 15, 2021 Montgomery College received notification that an additional \$20,493,396 would be available to award students under the American Rescue Plan Act (ARPA). In addition to the expanded eligibility given with the CRRSAA Act, HEERF III guidance with ARPA opens emergency grant eligibility to students who are Maryland Dreamers, DACA students, and other similar undocumented students, as well as International students studying under F1 and other visas types. Prioritization of the ARPA grant is based on exceptional need. First priority to domestic students, defined as Title IV eligible US citizens and eligible non- citizens, Dreamers and DACA qualifiers with exceptional need. Then F1 and other VISA holders with exceptional need are the next priority. ARPA as with CRRSAA can be used to cover any component of student's cost of attendance, emergency costs that arise due to coronavirus, such as: tuition; food; housing; health care (including mental); and childcare. ARPA can only be applied to tuition cost with the permission of the student.

2. Award Amount

MC received \$20,493,396 for ARP Act Emergency Financial Aid Grants to students.

As of October 7, 2021, MC has awarded \$1,996,428.

On July 15, 2021 we estimated at least 5879 MC students were potentially eligible to participate in our first awarding of ARPA grants based on enrollment during summer 2021. Of the 5879 students, two thousand one hundred seventy-nine (2179) completed an application. On September 23, 2021 we added to that estimate an additional 5880 students who entered MC for our fall 21 semester. These groups also included students who submitted applications and were enrolled in a previous eligible semester.

As of October 7, 2021, one thousand three hundred thirty-one (1331) student awards have been made through the student portion of the ARP Act Emergency Assistance Grant.

1. Statement of Use

On April 9, 2020, Montgomery College (MC) received notification that the College was awarded \$10,995,749 through the Coronavirus Aid, Relief, and Economic Security (CARES) Act, with no less than fifty percent (\$5,497,875) for Emergency Assistance Aid Grants to students. The guidelines from the U.S. Department of Education (ED) stated that these are direct emergency grants for students to cover expenses related to the disruption of campus operations due to the coronavirus (food, housing, course materials, technology, health care, and child care). The College must prioritize students with the greatest need and the funds may not be used to cover tuition and fees. MC signed the Certification and Agreement for the Emergency Financial Aid Grants to Students under the CARES Act on April 19, 2020, and received the allocation on April 24, 2020.

2. Award Amount

MC received \$5,497,875 for CARES Act Emergency Financial Aid Grants to students. The Financial Aid Office distributed an additional \$1,536,410 of the Higher Education Emergency Relief Fund I (HEERF I) Institutional Portion as emergency financial aid grants to students.

3. <u>Total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)</u> (1) of the CARES Act as of the date of submission.

As of October 7, 2021, MC has awarded the total \$5,497,875 to students from the student portion of the grant and the \$1,536,410 of the institutional portion.

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

As of May 19, 2020, we estimated 8,415 MC students were potentially eligible to participate in the program based on completion of a 2019-2020 Free Application for Federal Student Aid (FAFSA) and enrolled at the institution in on-campus classes at the time of the COVID-19 disruption. 7,102 of those students had completed all requirements for Title IV eligibility. The additional 1,313 completed the FAFSA but had not completed the verification process. By September 30, 2020, 8,936 became potentially eligible. 7,413 completed all requirements for Title IV eligibility and or met the basic Title IV aid matches. The remaining 1,523 never completed their file so we could determine eligibility. Funds that were not spent in 2019-2020 were moved into the 2020-2021 academic year. For these funds an application was required. Of the 3,488 students who applied, as of December 31, 2020, we were able to award 2,779 who met all eligibility requirements. One hundred seventeen (117) students awarded in 2019-2020 lost eligibility, most based on stale dated checks that could not be reissued. These recovered funds have also been moved to funding for 2020-2021. As of April 9, 2021, with the funds recovered from the stale dated checks and the institutional portion, we were

able to award the 132 remaining eligible students who completed our fall 2020 application. The additional institutional funds were evenly distributed to our most needy students enrolled for spring 2021. Between April 9, 2021 and July 9, 2021, we received \$11,500 in stale dated uncashed checks. Four thousand (\$4000) of that has been awarded to students who became eligible based on the additional HEERF II guidance. Between our July 9 reporting and this report, six (6) additional students lost eligibility either through unclaimed stale dated checks or confirmed lack of attendance. The remaining recouped funds were distributed to students with existing or new applications on file using updated HEERF III guidance.

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a) (1) of the CARES Act.

As of October 7, 2021, eight thousand seven hundred fifty-six (8756) student awards have been made through the student portion of the CARES Act Emergency Assistance Grant. One hundred forty (140) have been cancelled due to uncashed stale dated checks or confirmed nonattendance. Many students have received grants in more than one semester. This accounts for the difference in awards and students. Six thousand eight hundred ninety (6890*) students have active awards.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

In order to provide maximum support based on the funds available, the size of the award was initially based on the number of credits each student was taking. After student and institutional funds were awarded, the remaining institutional funds were evenly distributed to spring Pell Grant recipients. As subsequent funding became available and eligibility criteria changed with HERRF II and HERRF III, we moved from an amount based on enrollment hours to a standard grant amount for all.

- First Phase of Distribution Part 1 Awarded May 5, 2020, disbursed to students May 9, 2020
 - Spring 2020 Pell grant recipients enrolled for spring semester who did not completely withdraw. This is a group of students with documented financial need and Title IV eligibility. The change to remote instruction after March 13, 2020, affected them financially in increased technology costs, utility costs, child care costs, and loss of parent and/or student wages in at least the amounts listed above.
- First Phase of Distribution Part 2- Awarded May 21, 2020, disbursed to students May 22, 2020
 - Spring 2020 Subsidized Direct Loan recipients and additional Pell Grant recipients enrolled for spring semester who did not completely withdraw. This is a group of students with documented financial need and Title IV eligibility. The change to remote instruction after March 13, 2020, affected them financially in increased technology costs, utility costs, child care costs, and loss of parent and/or student wages in at least the amounts listed above.
- Second Phase of Distribution Part 1 Awarded July 31, 2020, disbursed to students August 1, 2020
 - On May 8, 2020, an online CARES Act assistance application form became available. MC students can state if COVID-19 disruptions have adversely affected them in one or more of the following areas: loss of income, food, housing, utilities, course materials, technology, health care, and/or child care.
 - Students who already completed a FAFSA for 2019-2020 or 2020-2021 and have already documented their Title IV eligibility, but did not already receive an award and maintained enrollment in Spring 2020, along with any students who met the criteria for Phase One and have not received the grant, were the first priority in this phase. Of the 5,697 students awarded, sixty (60) additional students were in this category.
 - Applications were accepted from May 8, 2020 through August 14, 2020. Two thousand one hundred and forty-nine (2,149) CARES Emergency Grant Applications have been received. Applications were screened based on the criteria in the proposed final rule. Based on eligibility criteria 117 applicants have been awarded. Many applicants already received the grant in the phase 1 distribution, and many others are not eligible. We

continued to screen applications to determine eligibility.

- Second Phase of Distribution Part 2 Awarded September 18, 2020, disbursed to students September 19, 2020
 - An additional 171 students who met either the First or Second Phase eligibility criteria and were enrolled in either spring 2020 or summer 2020 and had not already received a CARES grant in spring or summer 2020.

Third Phase of Distribution 10/10/20, 11/13/20, 12/11/20

■ Based on the awarding of both the First and Second Phases and the most recent Department of Education guidance for the disbursement of these funds, we have adjusted the criteria for Phase Three. On September 10, 2020 we made available to students our Fall 2020 CARES application. Three thousand four hundred eighty-eight (3,488) applications were received. Awards were made and funds disbursed on 10/10/2020, 11/13/2020 and 12/11/2020 to 2,779 of those 3,488, who in addition to submitting a CARES Grant application, also submitted a 2020-2021 FAFSA and met the required the Title IV eligibility criteria. The remaining 709 students will be awarded as they gain eligibility as long as funding is still available.

o Third Phase of Distribution 2/26/21, 3/26/21

Awards were disbursed on 2/26/21 and 3/26/21 to the 132 students of the remaining 709, who applied, and met all the eligibility criteria. These awards were made with the remaining \$62,775 of the student portion of the grant and \$59,000 of institutional portion funds.

Fourth Phase of Distribution 3/26/21

- New and additional awards were disbursed on 3/26/21 to Pell Grant students enrolled in the spring 21 semester. Identified as our most needy students and most affected by COVID-19, \$1,477,410 in the amount of \$370 was given to 3993 students.
- An additional \$4000 in awards were made to students in spring 2021 from funds recovered from stale dated checks. Another \$7500 remains to be spent. It, along with any other recouped funds, will be spent in summer and or fall 2021 using the additional eligibility criteria given in HEERF II and HEERF III.

Final Phase of Distribution 7/30/21 and After if needed

Recouped funds from stale dated checks or non-attendance allowed new and additional awards to be given to students who had an application on file, but either came after the initial funds were expended or may have not been eligible before HEERF II and HEERF III.

- Students who received grants in the first phases received an email notification from the MC financial Aid Office about the amount of the grant, what it is for, and why the student isreceiving it.
- o In the spring of 2020, the College President announced the receipt of the CARES Act funds and the Phase one disbursement of student emergency assistance grants. Communication from the Senior Vice President for Student Affairs introduced the availability of the new online CARES Act Emergency Assistance Grant application, the criteria, and how to apply for a grant.
- The MC Office of Communications is assisting with advertising the grant and the online application process.
- The grant availability is also announced through the MC Financial Aid Office's social media platforms.
- Email notifications have been sent to students with updates regarding CARES grant application processing and eligibility criteria.
- Students who have applied for CARES Emergency Grants, but are ineligible, receive notifications explaining why they are ineligible.
- As we have moved into the 2020-2021 academic year, the college administration, office of communications and the financial aid office continue to announce the availability of CARES grant funds and the application process.
- On 11/4/20 we closed the Fall 2020 CARES grant application. Recouped funds were used to award applications that had not been awarded.
- Students who remained ineligible for the CARES grant were sent notification, with a link to apply for the CRRSAA grant.

On February 16, 2021 we estimated 18,769 MC students were potentially eligible to participate in the program based on completion of a 2020-2021 Free Application for Federal Student Aid (FAFSA) and enrolled at the institution at the time of or after the COVID-19 declared emergency. As of May 24, 2021, an additional 471 students became potentially eligible. Of the 19,240 students, three thousand one hundred ninety-seven (3197) completed an application. We are continuing to award these students and also those additional students who have become eligible under HEERF III guidance.

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 314(a)(1) of the CRRSA Act.

As of October 7, 2021, three thousand two hundred twenty-nine (3229) student awards have been made through the student portion of the CRRSA Act Emergency Assistance Grant. One (1) award was canceled due to the student not meeting the eligibility criteria for CRRSAA. Many students have received grants in more than one semester. This accounts for the difference in awards and students. Three thousand ninety-nine (3099*) students have active awards.

As subsequent funding became available and eligibility criteria changed with HERRF III, we moved from an amount based on enrollment hours to a standard grant amount for all.

We required the FAFSA, since initial CRRSAA guidelines still required citizenship to be checked and an application to allow students to opt in or out of their grant paying tuition charges and attest to the other criteria.

CRRSAA Denial letters June 9, 2021

Students who did not meet the conditions for the CRRSAA grant were sent denial letters explaining why they were denied. The letter also gave them the link and encouraged them to apply for the new American Rescue Plan Act (ARPA) application which expanded eligibility criteria.

Remaining CRRSAA Funds as of June 30 ,2021

- It was requested by the college administration that we divide our CRRSAA allocation, spending some in spring 21, some in summer 21 and some in fall 21. The remaining \$2,211,874.00 will be spent as the updated Department of Education guidance now allows using the expanded HEERF III, ARPA criteria.
- o **Distributions**-July 30, 2021, August 13, 2021, August 20, 2021, August 27,2021, September 10, 2021, September 17, 2021 and October 3, 2021
 - Students with an application on file and now meet the original CRRSAA criteria or expanded criteria under HEERF III guidance.

- Workforce Development and Continuing Education (WDCE) students were not targeted with notifications because WDCE is still trying to allocate GEER funding to that population.
- Students who have applied for CRRSAA Emergency Grants, but are ineligible, received notification explaining why they are ineligible and a link to apply for the ARPA grant.
- On 5/26/2021 we closed the CRRSAA grant application and replaced it with the ARPA grant application.
