In conjunction with the renovation of the building, **ALL** asbestos-containing materials located in the Music Building have been removed.

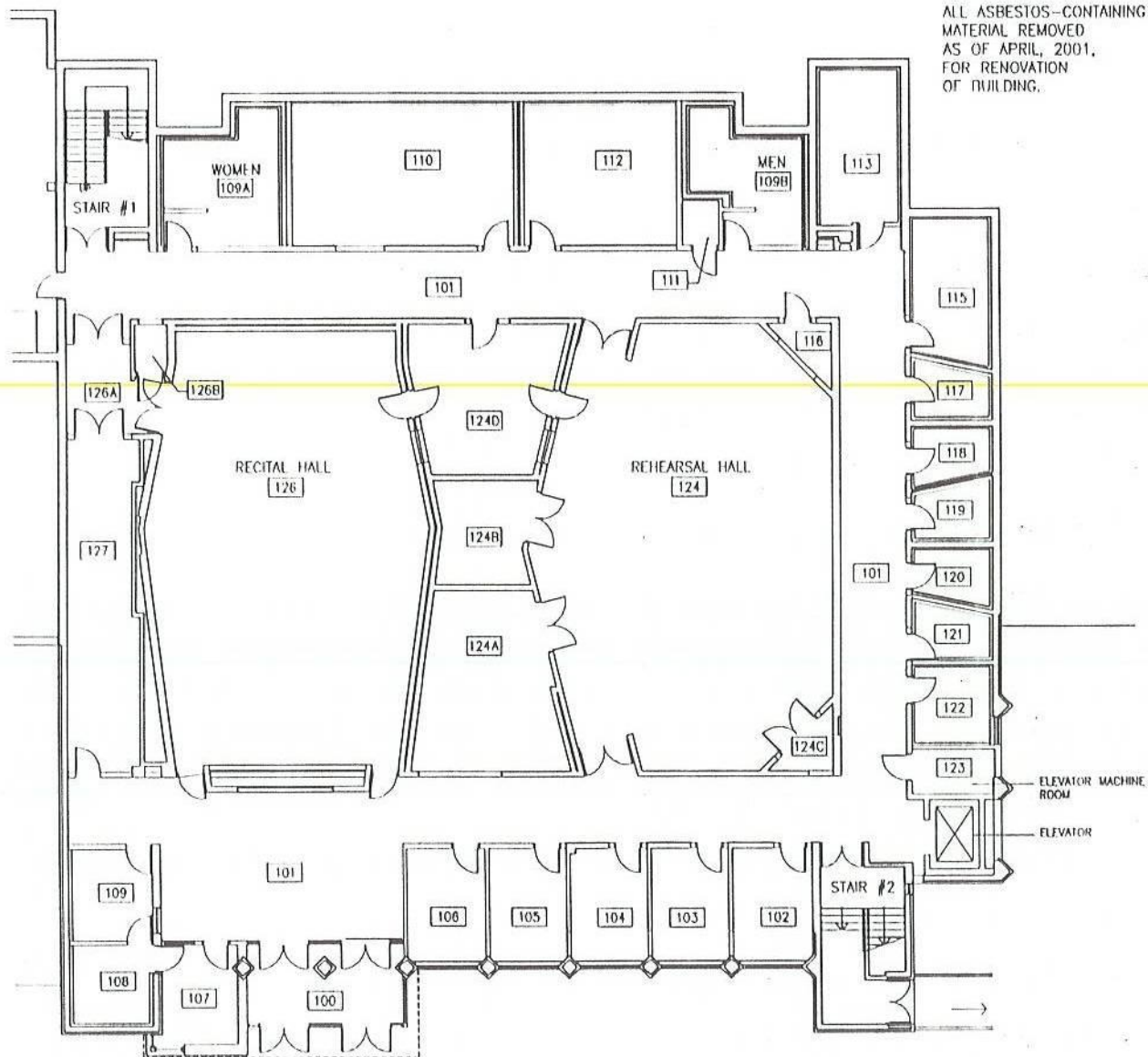

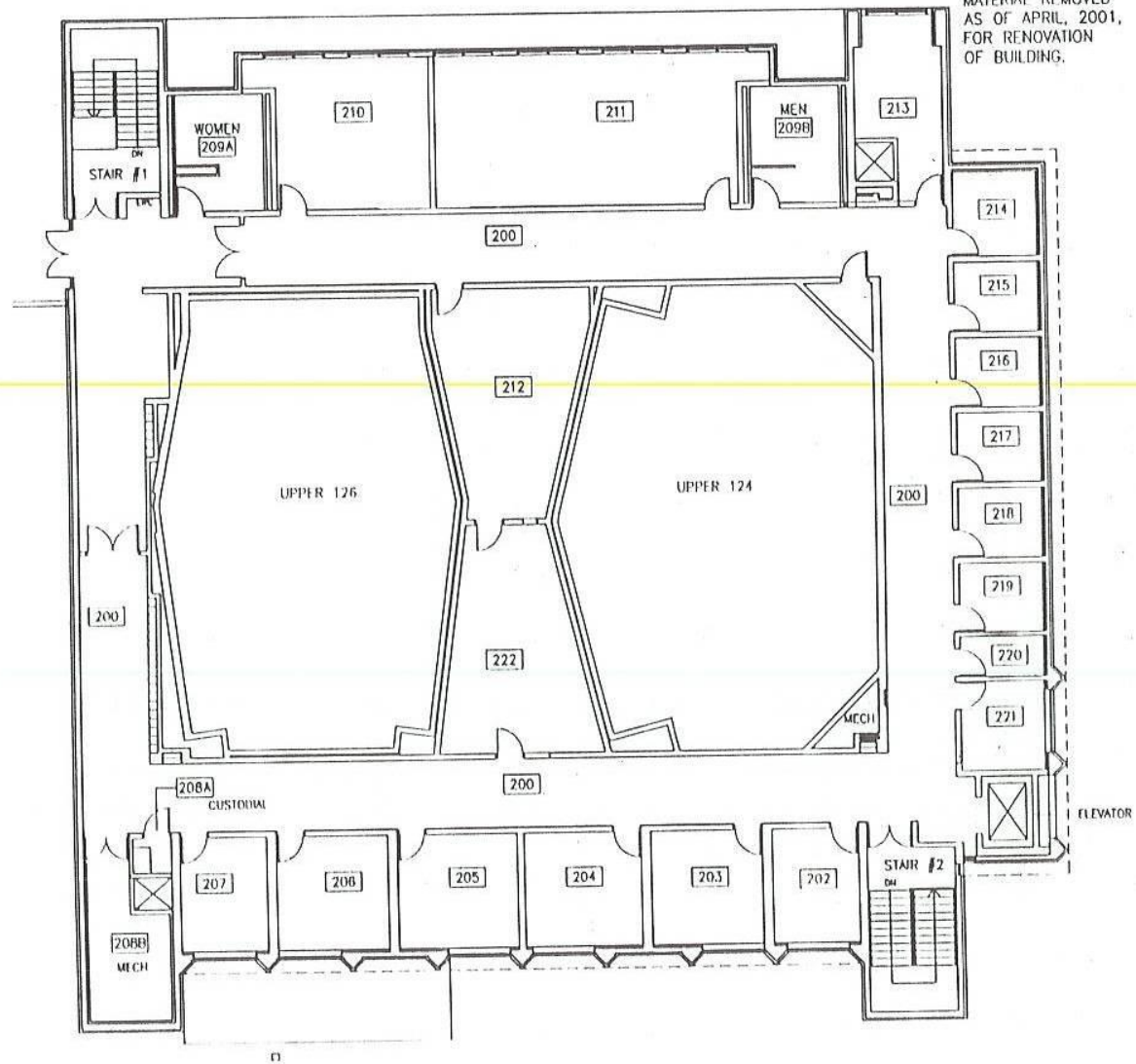

FIRST FLOOR PLAN

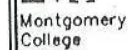
